

## ADVERTISEMENT OF BIDS

**Sealed Bids:** Sealed bids for the Streetscapes in Centerville for the City of Centerville will be received until 2:00 p.m., December 2, 2016 at the Centerville City Hall Building, 300 East Church Street, Centerville Georgia 31028, at which time and place they will be publicly opened and read. No bid may be withdrawn after the closing time for the receipt of bids for a period of sixty (60) days.

**Work to be Done:** The work to be done shall consist of furnishing all labor, equipment and materials necessary to install concrete sidewalks for the City of Centerville as shown on the plans. Construction shall consist of the installation of 2875 square yards of concrete sidewalk.

**Plans, Specifications, and Contract Documents:** Plans, Specifications, and Contract Documents are on file at Centerville City Hall. Copies may be obtained from Saunders Engineering Consultants, Inc., 104-C Gunn Road, Centerville, Georgia, 31028, Phone Number (478) 953-1228, Fax Number (478) 953-1248, upon payment of \$150 for each set (non-refundable).

**Bonds:** All bid bonds must be accompanied by a Bid Bond in an amount of not less than five percent (5%) of the bid amount. The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond in the amount of one hundred percent (100%) of the Contract amount and a Payment Bond in the amount of one hundred ten percent (110%) of the Contract amount in accordance with the Georgia Department of Transportation Specification 103.05. There is a 13% DBE Goal for this project.

The Georgia Department of Transportation Standard Specifications, 2013 Edition and applicable Supplemental Specifications and Special Provisions apply to this project. Bidders submitting bids over \$2,000,000 shall be prequalified with The Georgia Department of Transportation. Bidders submitting bids \$2,000,000 or less shall be prequalified or registered subcontractors with The Georgia Department of Transportation. This project will adhere to the Official Code of Georgia Annotated, Chapter 32, Sections 32-2-60 through 32-2-77.

The City of Centerville, in accordance with Title VI of the Civil Rights Act of 1964 and 78 Stat. 252, 42 USC 2000d-42 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, part 21, Nondiscrimination in federally assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, or national origin in consideration for the award.
