April 7, 2020

Meeting called to order by Mayor Harley at 7:00pm.

Welcome extended to all and roll call performed by Mayor Harley

Invocation given by Mayor Harley.

Pledge of Allegiance led by Mayor Harley

Present by teleconference Mayor John R. Harley, Councilman Cameron Andrews, Councilman Justin Wright, Councilman J. Micheal Evans, Councilman Edward Armijo, City Attorney Rebecca Tydings, City Clerk Krista Bedingfield and Director of Operations Mike Brumfield.

Mayor Harley stressed that he missed everyone. Trying to keep everyone safe.

Adoption of Minutes: Motion made by Councilman Evans to adopt both sets of minutes as written; seconded by Councilman Armijo. Motion carried. Unanimous.

Old Business

Ordinance 2020-2- Declaration of State of Emergency: Mayor Harley stated, “As you all are likely aware, on April 2, 2020 and April 3, 2020, Georgia Governor Brian Kemp issued three Executive Orders. The first Executive Order contained, among other things, a mandate for all Georgians to ‘in place.’ Two subsequent Executive Orders followed that helped to clarify the first Executive Order. Governor Kemp’s Orders preempt and, therefore suspend, the City of Centerville’s Declaration of State of Emergency and Ordinance adopted on March 24, 2020.”

“The purpose of adopting tonight’s Ordinance amendment is to ensure that the City’s Declaration and Ordinance go back into effect when and if the Governor’s Orders expire or are otherwise rescinded. Therefore, the effect of adopting tonight’s Ordinance amendment is that there will be local legislation in place in the absence of an Executive Order of the Governor by extending the effective period of the City’s Ordinance through 8:00 p.m. on May 5, 2020. It is the opinion and intent of the Governing Authority that the provisions of Centerville’s Declaration and Ordinance, Sections 5, 6, 11 and 13 related specifically to Centerville’s local operations do not conflict with the Governor’s Executive Orders and shall remain, at all times, in effect.”

Mayor Harley recognized City Attorney Tydings. Mrs. Tydings stated this ordinance is identical to the previously adopted Declaration of State of Emergency and Local Ordinance, the only change is the date is being extended until May 5, 2020. Motion made by Councilman Wright to

adopt as written; seconded by Councilman Armijo. Motion carried. Unanimous. See Ordinance 2020-3.

New Business

Recommendation of Award-2020 Centerville LMIG SEC Project # 1145: Councilman Andrews recognized Director of Operations Brumfield. Mr. Brumfield stated he provided copies of information in Mayor and Council packets for tonight. There is a letter of recommendation from Saunders Engineering Consultants, Inc. to award the 2020 LMIG contract to C.W. Matthews Contracting in the amount of \$ 162,460.42. Mr. Brumfield reminded everyone that earlier in the year Council had approved an estimated cost for project. The bid came in at approximately \$30,000 more than anticipated; however, this is the lowest bid received. Director of Operations Brumfield is asking that Mayor and Council approve the award to C.W. Matthews at \$162,460.42. Councilman Andrews made motion to award contract to C.W. Matthews Contracting in the amount of \$ 162,460.42; seconded by Councilman Evans. Motion carried. Unanimous. Councilman Evans inquired about why the cost went up approximately \$30,000, was there any change that caused this? Mr. Brumfield explained that bids came in a little higher price due to increase in the cost of asphalt. Will adjust line item in the budget to reflect change of cost.

Approval 2020 LMIG Contract & Authorization for Mayor to sign on behalf of City: Councilman Andrews stated this is self-explanatory. Motion made by Councilman Andrews to approve 2020 LMIG contract and authorize Mayor Harley to sign on behalf of the City; seconded by Councilman Wright. Motion carried. Unanimous.
