Approval Job Description - Special Events and Marketing Coordinator – Councilman Armijo recognized Director of Operations Brumfield. Mr. Brumfield referenced the job description in the folder and noted the changes to add “Marketing” and “Managing Social Media Platforms” and that this position would report to the Dir. Of Operations and also to remove the language highlighted in the description. Mr. Brumfield stated seeking approval of the new job description by M&C. Motion made by Councilman Armijo to adopt the job description for the position of “Special Events and Marketing Coordinator”, seconded by Councilman Evans. Motion carried.

Approval Premier Staffing Agreement - Councilman Armijo recognized Director of Operations Brumfield. Mr. Brumfield introduced the agreement with Premier Staffing, stating the City has used this company before and benefited with two great employees. Mr. Brumfield reviewed the fee stating Premier has a bill rate of 40% of the hourly pay rate of \$12.55 or \$17.57 per hour. The agreement is for 520 hours. Motion made by Councilman Armijo to approve the agreement with Premier Staffing Unlimited; seconded by Councilman Bird. Motion carried.
