## New Business

Home Based Business Licenses: Motion made by Councilman Wright to approve; seconded by Councilman Evans. Motion carried.

OPEB Trust Ordinance and Participation Agreement: Councilman Wright made motion to approve the OPEB Ordinance and Participation Agreement. This motion includes affirmation of the parameters of the program as follows: Pre-65 retirees who meet the Rule of 80 (age + years' service) shall receive medical/Rx insurance coverage and $\$ 10,000.00$ life insurance. The medical/Rx insurance will terminate at Medicare eligibility (age 65). These coverages are to be provided to employees only (no spouse of dependent coverage) with the city paying $100 \%$ of the premiums for the same. Finally, this motion also includes the authorization, for the Mayor and staff, to execute of all documents necessary to establish and carry out the OPEB Trust; seconded by Councilman Bird.

Councilman Evans stated this is a good thing that we are doing, awards long time employees, makes life easier, and helps keep great employees whom provide a great service.

Mayor called for vote. Motion carried.
Probation and Rehabilitation Services Agreement: Councilman Wright recognized Municipal Court Clerk Caldwell. Ms. Caldwell stated this is the same agreement and it has to be renewed
every 5 years. City Attorney Tydings has reviewed agreement. There were some grammatical errors; however, content has not changed.

Motion made by Councilman Wright to approve and authorize Mayor Harley and City Attorney Tydings to sign and execute appropriately; seconded by Councilman Bird. Motion carried.
