DECLARATION OF LOCAL EMERGENCY

WHEREAS, Centerville, Georgia will experience an event of critical significance as a result of Tropical Storm Helene on September 26th, 2024.

WHEREAS, the Governor has declared a state of emergency for entire state of Georgia, including Houston County and the City of Centerville.

WHEREAS, in the judgment of the Mayor and Council of the City of Centerville, with advice from the Director of the Houston County Emergency Management Agency, there exist emergency circumstances located in Centerville, Ga. including the Cities of Warner Robins, Perry, and Houston County requiring extraordinary and immediate corrective actions for the protection of the health, safety, and welfare of the citizens of Centerville, including individuals with household pets and service animals; and

WHEREAS, to prevent or minimize injury to people and damage to property resulting from this event, certain actions are required.

NOW, THEREFORE, pursuant to the authority vested in me by local and state law.

IT IS HEREBY DECLARED that a local state of emergency exists and shall continue until the conditions requiring this declaration are abated.

THEREFORE, IT IS ORDERED:

(1) That the City of Centerville activates the Emergency Management Provisions within the Centerville Code of Ordinances; Chapter 18 Article 1- Chapters 18-1 through 7 to wit:

ARTICLE I. - EMERGENCY MANAGEMENT

Sec. 18-2. - Emergency management and response power

Sec. 18-3. - Enforcement and remedies

Sec. 18-4. - Authority to waive procedures and fee structures
