New Business

Presentation Pivotal Housing Partners-"The Villas on Gunn"-Mr. Pete Schwiegeraht: Councilman Justin Wright introduced Mr. Schwiegeraht, the Senior Vice President of Development for Pivotal. The company has over 30 years of experience and 10,000 units across 12 states, including six developments in Georgia, from Brunswick to Douglasville, including a nearby property in Gray, Georgia. Mr. Schwiegeraht presented to the governing authority a potential project called "The Villas on Gunn". A senior village with 70 to 75 single-story ranch cottage-style units, which will be located on the north side of Gunn Road, west of city hall next to the Centerville Library. Each unit would be built to ADA standards, 100% disabled accessible and visitable, with zero-step entry, a modern open floor plan with 1 to 2 bedroom options, to include in-unit washers and dryers and walk-in closets. The units would be forward facing, towards Gunn Road, with sidewalk connections and landscaping features. There will be a clubhouse with a community room and fitness center on-site, as well as, a 3/4 acre greenspace with patio/recreational area. There will an additional 2000 feet of new sidewalks added along Gunn Road connecting from the library. Construction is anticipated to start in March of 2026, with completion by mid-2027, and full occupancy by the end of 2027. No motion or action was taken.

<u>Approval A2Z Performance Agreement IDC Event:</u> City Administrator Krista Bedingfield presented to the governing authority a musical performance agreement with A2Z band for the June 27th Independence Day celebration, requesting authorization to move forward and allow Mayor Pro Tem J. Micheal Evans to sign agreement.

Motion made by Councilman Edward Armijo to sign agreement as written; seconded by Councilman Robert D. Bird, Jr. Motion carried. Unanimous.

<u>Approval Pyrotecnico Agreement IDC Event:</u> City Administrator Krista Bedingfield presented to the governing authority an agreement with Pyrotecnico to provide fireworks for the June 27th Independence Day celebration, requesting authorization to move forward and allow Mayor Pro Tem J. Micheal Evans to sign agreement.

Motion made by Councilman Justin Wright to sign agreement as written; seconded by Councilman Edward Armijo. Motion carried. Unanimous.

<u>Ordinance - Re-zoning 813 N. Houston Lake Boulevard:</u> City Administrator Krista Bedingfield introduced Mr. Franklin "Todd" Robinson. Mr. Robinson submitted his request to the governing authority to rezone property at 813 N. Houston Lake Road from R1 to C1, in order to have a State Farm Insurance company at this location. There would be a parking lot established, regular working hours, and minimal traffic.

Motion made by Councilman Edward Armijo to approve ordinance as written; seconded by Councilman Justin Wright. Motion carried. Unanimous. (Ordinance 2025-2).

A representative for Patriot Development LLC, engineer, Steve Rowland, presented the governing authority additional information about entrances and sidewalks.

Motion made by Councilman Justin Wright to approve ordinance as written; seconded by Councilman Edward Armijo. Motion carried. Unanimous. (Ordinance 2025-3).
