<u>Discussion 2025 Millage Rate Option (2025 Property Tax Rate):</u> City Accountant Carol Harrison and Mayor J. Micheal Evans acknowledged that this is an annual requirement. The millage rate (property tax rate) must be set annually to determine city tax revenue for operational expenses (payroll, equipment, street paving, cleanliness, fire services, etc.). The current millage rate is 9.5 mills, the calculated rollback rate is 8.367 mills, and the middle-ground rate proposed is 8.90 mills. City Accountant Harrison explained that anything above the roll-back rate would have additional requirements, such as advertising and holding public hearings. Mrs. Harrison provided an overview and examples of how the Floating Homestead Exemption would affect the local homeowner, which came about through House bill 581. This an exemption for owner-occupied homes (up to 5 acres), excluding businesses and rental properties.

Motion and Vote: 1st motion by Councilman Bird motioned to adopt a millage rate of 8.9 mills for the current tax year; 2nd motion by Councilman Armijo; Unanimously approved after clarifying requirements for ad publication and public hearings.
